



## ESTABLISHMENT OF AN ACADEMIC ENDOWED SCHOLARSHIP

The Santa Fe Community College (SFCC) Foundation is a non-profit, tax-exempt 501(c) (3) public charitable foundation established solely to foster and promote the growth, progress and general welfare of Santa Fe Community College. Gifts to the SFCC Foundation are deductible for income tax purposes as provided in section 170 of the Internal Revenue Code. The SFCC Foundation's Endowed Academic Scholarship provides tuition, lab fees, special course/program fees and textbooks for each semester. The minimum amount required to establish an Endowed Academic Scholarship is currently \$10,000. Your donation may be made in monthly or quarterly payments. The full amount must be paid within one year and an initial deposit of \$1,000 is required. Funds are awarded after the first anniversary of the establishment date. It is the policy of Santa Fe Community College that discrimination against any individual in the United States on the basis of race, color, religion or creed, national origin, ancestry, gender, gender identity, sexual orientation, age, physical or mental disability, serious medical condition, spousal affiliation, veteran status, pregnancy, genetic information, citizenship, and any other basis is specifically prohibited.
